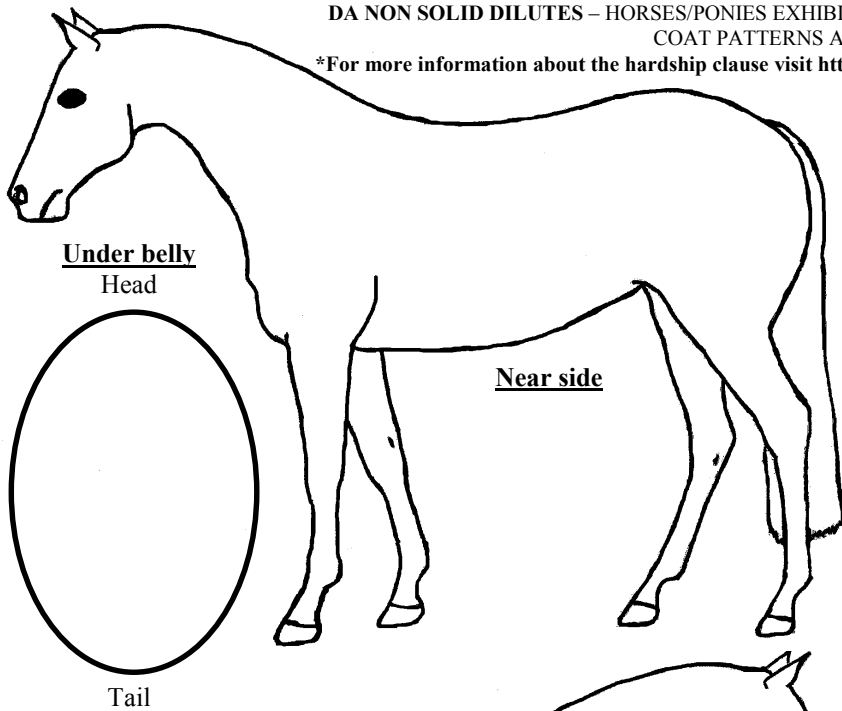

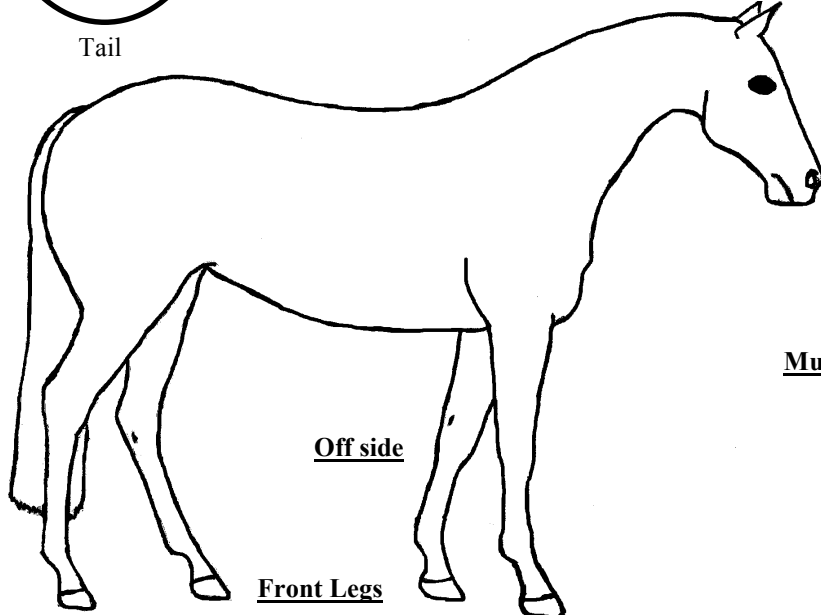
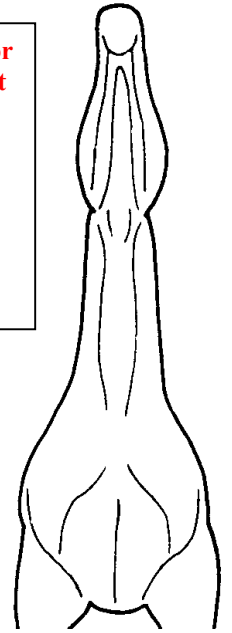

WHITE SPOTS CAUSED BY RUBBING AND ACCIDENT DO NOT DISQUALIFY. PLEASE NOTE THAT ALL HORSES THAT ARE NOT ALREADY REGISTERED UNBRANDED WITH ANOTHER BREED SOCIETY **MUST BE BRANDED BEFORE THIS REGISTRATION WILL BE PROCESSED.**

**DA NON SOLID DILUTES** – HORSES/PONIES EXHIBITING TOBIANO, OVERO, SABINO, SPLASH OR APPALOOSA COAT PATTERNS ARE NOT REQUIRED TO COMPLETE THE BODY MARKINGS.

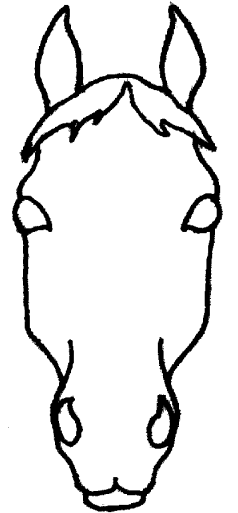

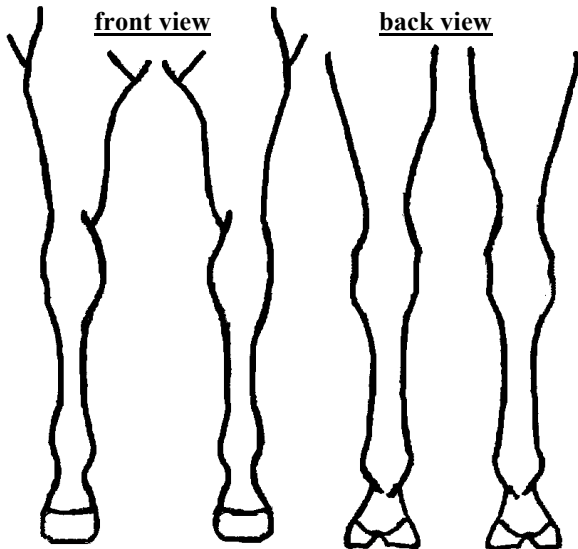

Muzzle

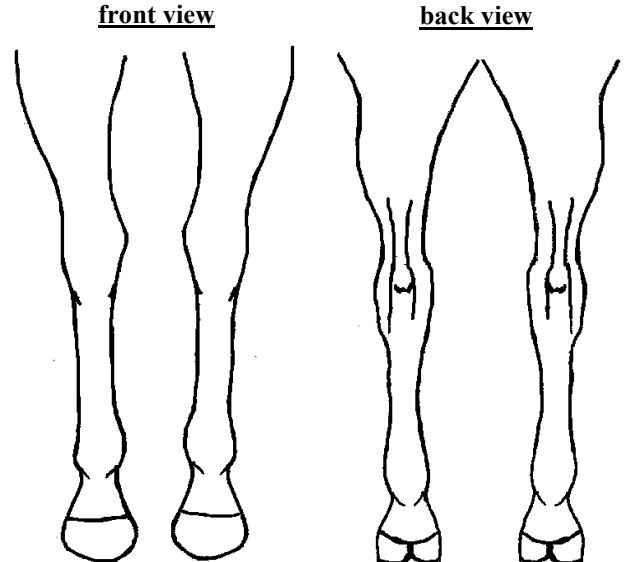


Hind Legs
